LYONS RURAL FIRE PROTECTION DISTRICT VETERANS' PREFERENCE INFORMATION AND INSTRUCTIONS



Veterans' preference points cannot be awarded without required documentation.

If you are seeking veterans' preference in employment, please complete the attached form and return it with your supporting documentation.

Under Oregon law, armed forces veterans who meet minimum qualifications for a position may be eligible for employment preference. You may be eligible for either 5 points as a Qualified Veteran, or 10 points as a Qualified Disabled Veteran (or spouse), but not both. If you are a veteran and want to apply for preference points, please submit a completed Lyons Rural Fire Protection District Veterans' Preference form as well as the required documentation listed on the form. You may submit the documentation to Lyons Rural Fire Protection District in several ways:

- 1. Attach your completed Veterans' Preference form and documentation to your application when you apply for a position with Lyons Rural Fire Protection District; or
- 2. Scan the form and documentation and email it to Lyons Rural Fire Protection District, www.lyonsfire@lyonsrfd.org or
- 3. Mail or hand-deliver the form and documentation Lyons Rural Fire Protection District, 1114 Main St./PO Box 179 Lyons OR 97358.

Definitions:

"Active duty" does not include attendance at a school under military orders, except schooling incident to an active enlistment or a regular tour of duty, or normal military training as a reserve officer or member of an organized reserve or a National Guard unit. Any discharge date is now eligible.

"Veteran" means a person who:

(A) Served on active duty with the Armed Forces of the United States;

- 1. For a period of more than 178 consecutive days and was discharged or released from active duty under honorable conditions; or
- 2. For 178 days or less and was discharged or released from active duty under honorable conditions because of a service-connected disability; or
- 3. For at least one day in a combat zone and was discharged or released from active duty under honorable
- 4. conditions; or
- (B) Received a combat or campaign ribbon for service in the Armed Forces of the United States.

"Disabled Veteran" means a person entitled to disability compensation under laws administered by the United States Department of Veterans Affairs, a person whose discharge or release from active duty was for a disability incurred or aggravated in the line of duty or a person who was awarded the Purple Heart for wounds received in combat. Qualifying spouse may claim points with County verification of status on DD214 or an employability or eligibility letter.

"Armed Forces" means the United States Army, Navy, Marine Corps, Air Force, and Coast Guard, including the reserve components thereof. Reserve components mean:

- (a) The Army Reserve;
- (b) The Navy Reserve;
- (c) The Marine Corps Reserve;
- (d) The Air Force Reserve'
- (e) The Coast Guard Reserve;
- (f) The Army National Guard of the United States; and
- (g) The Air National Guard of the United States.

Under Oregon law, armed forces veterans may be entitled to preference in employment or promotion. If you think you may qualify, please read the following information carefully and check the box(es) in each section appropriate to you.

QUALIFIED VETERAN: You may claim veterans' preference if you are able to check one or more boxes in this section and provide proof of veterans' preference eligibility by submitting a copy of your Certificate of Release or Discharge from Active Duty (DD214/DD215 that reflects your "Honorable" separation status) at the time you submit your completed employment application. **Preference will not be applied unless we receive the appropriate documentation prior to the date of the written test.**
